
Collie Club of America 2013 National Specialty Herding Test /Trial

Welcome to Collie Club of America National Specialty Herding Test and Trial!

There has been a **CHANGE OF VENUE** for this show due to conditions at the original trial site.

The new site is in a horse arena - 130 x 260. AKC gave permission to have B Ducks in the smaller space. Sheep trial classes will run counter clockwise. A Ducks will run clockwise. B Ducks will have a right-hand drive. Cattle panels enclose the arena. The arena has rounded corners but is not oval; there is walking area between panels and building wall. The area for setout / exhaust is the same so the course features will be the same ... mirrored. There will be orange fencing around the arena and chicken wire where people will be sitting so you can see.

There is room for spectators but no crating so dogs will have to be in the cars. Quiet dogs can come in prior to

their running time. There is a warm room in adjacent building with running water toilets. We will have good lunches where you can warm up and visit. Secretary will be in that room along with prizes and raffle items. Bring chairs.

Herding Instinct testing will follow the trial. Due to the late change of venue, there will be no Saturday night dinner.

Fort Atkinson, WI is centrally located in Southern WI with the highways converging there. There are many choices of hotels in the area.

Directions:

From Northwest: I-94 to WI 73 S. Left on US12/US18/WI 73 S. Follow US12 E to WI-26, right on WI26. Exit WI 106 E. Right on Blackhawk Island Rd. Left on Christie Ct. You will see white fencing on your left and that is the place. Drive back to buildings. **From Northeast**: I-94 to 26 S, go 14.7 miles


Exit on WI 106 E, then directions as above.

From Southwest: 139/190 to 26 N, go 15.4 miles. Exit WI 106 E, then directions as above.

From Southeast: Take US 12 north into Fort Atkinson. Turn left on Sherman Ave. W, then a slight left onto WI 106. Turn left on Blackhawk Island Rd, and Left on Christie Ct. You will see white fencing on your left and that is the place. Drive back to buildings.
