Thank you for entering Fox Valley Dog Training Club's obedience and rally trials. These events are being held at the Kane County Fairgrounds, 525 S. Randall Road in St. Charles, IL.

Important note on the show site: You are no longer able to turn left into the fairgrounds from northbound Randall Rd. We recommend you turn left (west) at the Oak Street light, after the fairgrounds. Use the Costco parking lot on your right, to turn around and exit left (east) back onto Oak Street. Then turn right (south) onto Randall Road to get to the fairgrounds entrance.


Running order for both Rally and Obedience will be small to tall on Saturday (except for Utility B which will be tall to small) and tall to small on Sunday (except for Utility B which will be small to tall). We will run in catalog order on Saturday; classes with jumps will run in reverse catalog order on Sunday to effect the jump height change.

Please check the included entry information for your dog(s). If you find any errors notify the trial secretary via email at secretary@livetrial.net or phone at (630) 790-8426. The secretary will be reachable on the day of the trial at (630) 456-0097.

The building will be open at 8:00 a.m. Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Each judge will take a lunch at his/her discretion.

Coffee and cookies will be provided to exhibitors at no charge. Exhibitors may not set up on Friday or before 8:00 a.m. on Saturday. Crating space and exercise areas will be designated; please use the appropriate areas for each.



POLISH YOUR PERFORMANCE!

At the close of Saturday's trial, exhibitors may practice in one ring of their choice for 8 minutes for \$10.00. Exhibitors may sign up for a novice, open, or utility ring beginning at 10 am at the front table. Exhibitors must sign up in person & pay at that time. Each exhibitor may use the ring of their choice once for each dog which is entered in the trial. Entries will close when the number of dogs entered in each ring reaches 18.

On Sunday there will be a backdrop and decor which exhibitors may use to take selfies of their dogs or have a friend do so. We ask that exhibitors taking advantage of this photo op be considerate of dogs who are in the rings.


