

Fox Valley Dog Training Club AKC Obedience and Rally Trials November 18 – 19, 2017



Thank you for entering Fox Valley Dog Training Club's obedience and rally trials. These events are being held at the Kane County Fairgrounds, 525 S. Randall Road in St. Charles, IL.

Important note on the show site: You are no longer able to turn left into the fairgrounds from northbound Randall Rd. We recommend you turn left (west) at the Oak Street light, after the fairgrounds. Use the Costco parking lot on your right, to turn around and exit left (east) back onto Oak Street. Then turn right (south) onto Randall Road to get to the fairgrounds entrance.

Running order for both Rally and Obedience will be small to tall both days.

Please check the included entry information for your dog(s). If you find any errors, notify the trial secretary via email at secretary@livetrial.net or phone at (630) 790-8426. The secretary will be reachable on the day of the trial at (630) 456-0097.

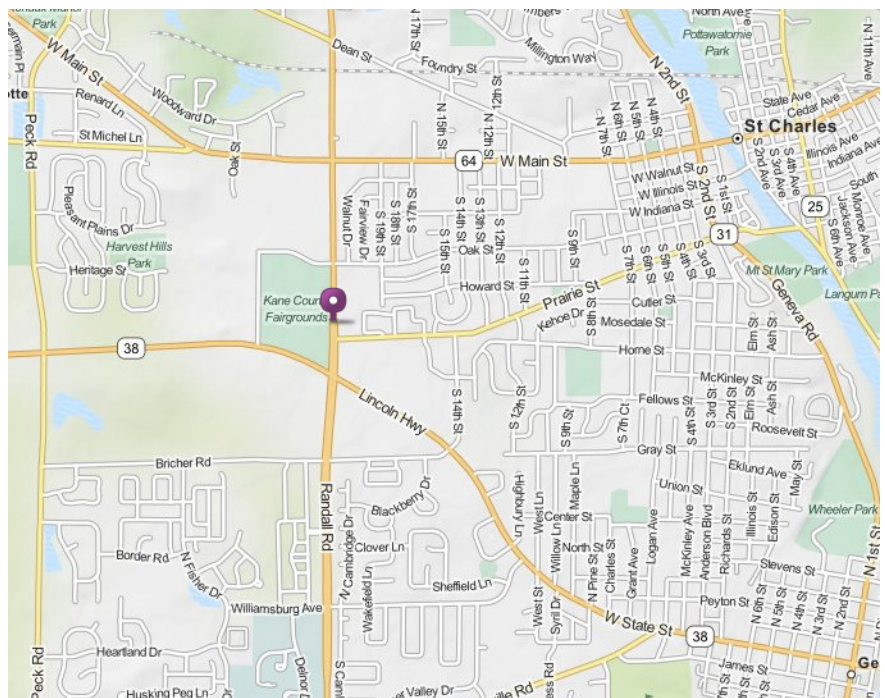
The building will be open at 7:00 a.m. Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Each judge will take a lunch at his/her discretion.

Coffee and cookies will be provided to exhibitors at no charge.

Exhibitors may not set up on Friday or before 7:00 a.m. on Saturday.

Crating space and exercise areas will be designated; please use the appropriate areas for each.



POLISH YOUR PERFORMANCE!

At the close of Saturday's trial, exhibitors may practice in one ring of their choice for 8 minutes for \$10.00. Beginning at 10:00 a.m. at the front table, exhibitors may sign up for a novice, open, or utility ring. Exhibitors must sign up in person and pay at that time. Each exhibitor may use the ring of their choice once for each dog, entered in the trial. Entries will close when the number of dogs entered in each ring reaches 18.

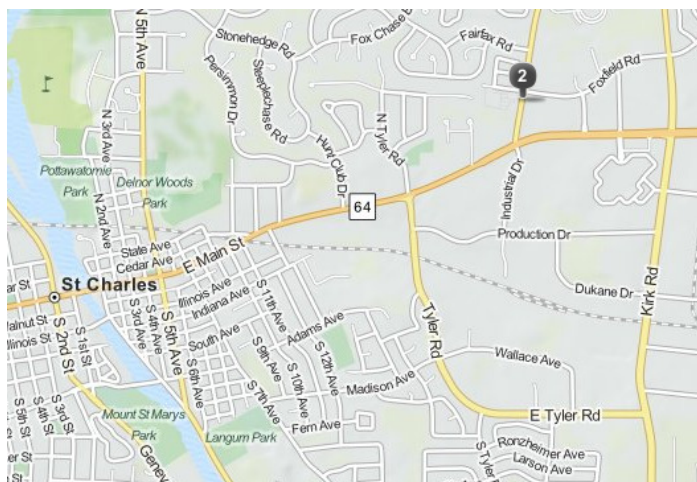
Directions to vet from show site:

Judging Schedule

There are 108 dogs in the obedience trial and 36 dogs in the rally trial, with 144 obedience entries and 44 individual plus 4 team rally entries for a total of 192 entries.

Start times are calculated based on AKC guidelines that the following number of dogs are judged per hour:

Beginner Novice – 10; Novice, Preferred Novice – 9; Graduate Novice, Preferred Open, Open – 8; Graduate Open, Preferred Utility, Utility – 7; Versatility – 6; and Rally - 20
