Except for the first class of the day in each ring, all start times are approximate. Dogs in the “B” classes will run first, followed by dogs in the “A” classes for each jump height. Dogs in the Preferred program will run after dogs in the “A” classes in their corresponding jump height. Walk-throughs may be split at the discretion of the judge.

**ARMBANDS:** Your armband will be available at the check-in table, along with course maps and running orders for the day. If you need to be measured, an AKC rep will be onsite to provide official measurements.

**PARKING:** There is exhibitor parking in front of 1975 Cornell Ave and behind the building. You may park on the west side of Cornell Ave but not in front of 1-800 Flowers on the north side of our building.

**CRATING:** Please be considerate to your fellow exhibitors and use the space as efficiently as possible. No setup available Friday night.

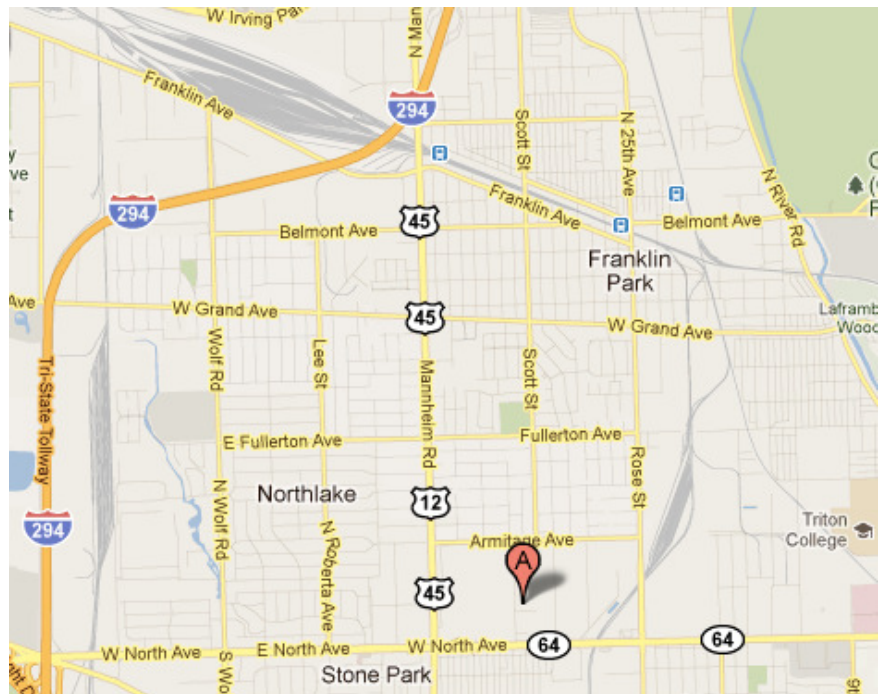
## DIRECTIONS TO TRIAL SITE

For Your Canine, Melrose Park  
1975 Cornell Ave.  
Melrose Park, IL 60160-1001

**From the South** take Interstate 294 North, exit Interstate 290 towards Rockford, exit North Ave. East. Go to Cornell Ave. make a left to 1975.

**From the North** take Interstate 294 exit Irving Park Rd west, go to Mannheim Rd make a left (Southbound). Go to Armitage Ave make left (East) then go to Cornell Ave make a right (South) to 1975.

**From Chicago** take Interstate 90 to Interstate 190 towards O'Hare exit Mannheim Rd South to Armitage Ave. Left onto Armitage then go to Cornell Ave make a right to 1975.
