The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Please remember lunch will not be provided so prepare accordingly.


Each judge will take a lunch at his/her discretion.

DIRECTIONS TO TRIAL SITE: Stone City Kennel Club is located approximately 4 miles west of Rt. 45, or 1 mile east of Cedar Road on Laraway Road in New Lenox.

FROM I-80 (eastbound) take Rt. 30 exit south. Go 1.5 miles and turn right onto Cedar Road. Go 2 miles and at 4-way stop sign turn left (east) onto Laraway and go 1 mile. Clubhouse is located on the North side of the road. **FROM I 80 (westbound)** take Rt 45 exit south. Go 5.6 miles and turn right onto Laraway Road and go approximately 4 miles west. Clubhouse will be on your right.
