This club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

Alternates List: Runs limited to 50. Entries received after the numerical limits have been reached but prior to closing will be placed on an alternates list. If you DO NOT wish to be on the alternates list, please enclose a signed statement to that effect with your entry. The alternates list will be used to fill vacancies in the drawn running order, with the first available alternate entry replacing the first vacancy in the class entered.

Per Chapter 1, Section 13 of the Herding Regulations, "In tests and for move-ups from a test class to a trial class, alternate entries shall be given priority over dogs that are eligible to be moved-up. Within the trial classes, requests to move-up shall be given priority over alternate entries.

Alternates will be permitted to run if there is an absentee in an earlier class (provided the alternate's class has not begun) which was not filled on the same course, same type of livestock and under the same Judge, or if a dog has been marked absent with the Event Secretary prior to the beginning of the alternate's class."

Entry fees will be refunded for alternates whose dogs do not run.

Bitches in season will be placed at the end of the running order in test classes and run in catalog order in trial classes. Please notify Trial Secretary if your bitch is in season.

From Tulsa: Take US-412 to the Cimarron Tpke. Go 43.8 mi on US-412 (Cimarron Tpke West) to the US-177/Stillwater/Ponca City exit. Exit right then turn left (north) onto US-177. Go 20.6 mi to US-60 (do not take US-60 Business) and turn right (east). Go 3.1 mi to Hunt Rd. and turn right (south). Go 2.5 mi and turn left (north) onto Wilde Rd. go approx. 1/3 mi to trial site.

From Oklahoma City: Take I-35 North approx. 86 mi to the US-60/Tonkawa/Ponca City exit 214. Exit right (east) onto US-60 (do not take US-60 business) and go approx. 18.6 mi to Hunt Rd and turn right (south). Go 2.5 mi and turn left (north) onto Wilde Rd. go approx. 1/3 mi to trial site.

From Wichita Kansas / Oklahoma State Line: Take I-35 South approx. 20.9 mi to the US-60/Tonkawa/Ponca City exit 214. Non-regular class: Pre-Started Sheep A Course

Offered only on Saturday, March 7, 2015.

Pre-Started A

This is a non-titling class, open to collies who have not, at the time of the show's closing, obtained a qualifying score on an AKC A Sheep course. The class will be run on the AKC Started A course using the AKC Started A rules, except for the following modifications. Except for the modifications noted here, the judge will score each run in the same manner as Started A, and all AKC rules will apply. The class will be run after both A and B sheep are completed for the day and may be either sheep or goats. However, the entire class will be run on one stock or the other and will not be mixed either by set or by run.

The stock will be set in the same location as for the A course runs.

However, while the dog must start at the B cone, handlers may position themselves anywhere on course prior to sending the dog. (Consistent with the AKC rules for the Pretrial class, the dog must demonstrate a controlled pause before the handler sends it.) Handlers may move freely about the arena at any time; stock need not cross the A cone line before handlers may move beyond it.

- Handlers may take dogs to the starting point on-leash and may keep the dog on leash until the stock are set in the arena.
- After the dog has gathered the stock, the handler will drive or fetch the stock to the C cone in as efficient a manner as possible and will then continue along the course in the same manner as for Started A.
- The handler may walk through the Y-chute and the runway panel, but may not walk through the Z-chute.
- At the repen, the handler need not demonstrate a hold at the gate, but may repen the stock in the same manner as is permissible under the AKC rules for the Pretrial class.
- After closing the repen gate, the handler may put the dog on-leash at any time or location in the arena.
- Since this is a non-titling, non-regular class, there is no minimum "qualifying" score. However, no score will be awarded if the handler calls time prior to completing the run or if the judge removes or excuses the dog. Placements will be awarded for first through fifth place based on score, with ties broken by the score on the cross-drive, followed by time.
- Please note: Scores from this class do <u>**not**</u> count towards the Most Versatile Collie award.

Practice Run Information

A one-day Collie herding camp will be held at Ability Stockdogs on Wednesday, March 4. Private lessons are also available during the week. Practice runs on goats and ducks are available on Thursday, March 5, and Friday, March 6, using A and B courses and/or the test arena.
