The owner or handler of each dog is solely responsible for having their dog ready at ringside at the scheduled time. The Club will not be responsible for and is not obligated to call or locate dogs that are not brought into the ring when required. Break for lunch to be determined by the judge.

TRANSFER OF ENTRIES: Entrants wishing to transfer from Regular conformation classes to Best of Breed or Junior Show entrants wishing to move to Open or Master must submit their requests in writing to the Secretary no later than 30 minutes prior to the start of judging for the day.

COVID PROTOCOLS & ADDITIONAL SHOW INFO

Masks will be required when inside the building, and outside when appropriate social distancing cannot be observed.

NO grooming inside the building – covered areas are available outside, under the open-sided Barn extensions for crating & grooming. Please follow posted layout! **Very limited** electric will be available outdoors.

Private pop-ups are allowed to be set up by your vehicles in designated areas.

Crating (*courtesy crates*) will be allowed inside the building in designated areas **ONLY** to facilitate the exchange of dogs between classes, only. **NO** tables! **NO** Chairs! **NO** grooming! Social Distancing must be observed.

Battery operated; individual crate fans will be allowed to be hung on crates indoors if desired. **NO** floor fans will be allowed.

Armbands will available ringside immediately before each class or group of classes. Please know your armband number. **NO** catalog will be available to look at.

Show Secretary will be available **ONLY** for move-ups or entry discrepancies.

Spectators will be allowed in **designated areas** – you must bring your own chairs and observe social distancing.

Fairgrounds gates open at 8:00 a.m. on Friday. 7:00 a.m. on Sunday. Parking at the direction of the club parking director.

Building opens at 9:00 a.m. on Friday. 7:30 a.m. on Sunday

Show starts at 3 p.m. or one hour following the end of first show on Friday. 9:30 a.m. on Sunday.

NO set up of *courtesy crates* indoors until 7:30 a.m. on Sunday. You may leave your crates from Friday, Saturday shows there if you are showing on Sunday.

NO building or parking lot access on Thursday

The building is not air conditioned. Weather permitting, windows and doors will be open. Battery operated; individual crate fans will be allowed to be hung on crates indoors if desired. **NO** floor fans will be allowed.

NO Coffee or donuts will be available in the morning.

Lunch will be available for purchase for a limited time each day.

YOU are responsible for cleaning up after yourself and your dogs in all indoor **AND** outdoor areas. This includes dog hair, food and drink containers, and dog waste. Please leave the space you use as you found it!

NO ex-pens inside any barn areas or exercising of dogs inside any barn areas.

From Route 50 or 45: Go to Laraway Road or Route 30. Turn West to SchoolHouse Road, turn Right. (just West of Wolf Road - Stop Sign if coming off of Laraway, Stop Light if coming off of Route 30); Deadend on Francis Road - turn Left. The 4H field will be on your right about a mile down.
