**TRANSFER OF ENTRIES:**Entrants wishing to transfer from Regular conformation classes to Best of Breed, Junior Show entrants wishing to move to Open or Master, or Rally/Obedience entrants wishing to move up to the next level of competition, must submit their requests in writing to the Secretary no later than 30 minutes prior to the start of judging for the day.
