WELCOME

Welcome to first Car-Dun-Al AKC Scentwork Trial! We hope you all have a great time.

The building opens at **7:00 a.m.** each day. Please do not arrive earlier than this, per the hosting site requirements. See the judging schedule for the start time for your classes.

No setup on Friday night.

Please review your enclosed entry information. If there are any errors or problems, please email the trial secretary at secretary@livetrial.net (preferred) or phone (815) 242-5483. Except for the first class of the day in each ring, all start times are approximate.

SITE INFORMATION: As always, clean up after your dog. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions. We'd like to be able to keep using these hotels for dog shows, so please continue to be exemplary dog owners.

FOOD: Food will be *not* available for purchase on-site.

CRATING: Please, no X-pens allowed. Crate in the marked crating areas.

PARKING: No parking is allowed in front of the gymnastics building. Please do not allow your dogs to bark in the car.

ELEMENT RUN ORDER: Both Trial 1 Briefings will be at 7:45 A.M with the first dog on the line at 8:00 A.M. Trial 2 Briefings will be at 12:30 P.M.. All exhibitors will have the opportunity to see all search areas prior to running. Subsequent class briefings will be held after the completion of the prior class. Judging of Interiors and Containers / Buried will be held concurrently in each trial. All elements to be held Indoors. Judges have the right to make organizational changes when needs of the event would benefit.

SITE CONFIGURATION: For those familiar with the CDA agility setup, the area where the agility secretary typically is set up is going to be part of the interior search area. The two entrance doors on that side of the building (the south end) will remain locked all day. The running orders and results will be posted on the two garage doors you have to pass to get to the restrooms. ALL CRATING WILL BE BEHIND THE WOODEN BARRIER. Crating will not be available near the search areas, staging area or the trial secretary's area. Participants will be using the crate area used for agility trials.

Since the Master and Novice levels will be running at the same time we will have two different areas with warm up boxes and each will have the appropriate odors for that particular level being searched. The plan is to have a chair near the entrance to each search area. One person will be searching, we'll have the next person waiting in the chair and the person to follow on the warm up boxes. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior their run. The warmup area is not for training or relieving of the dog. Judges will give direction for this in their briefing.

The Handler's Briefing will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo (White) Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. Judges will also provide any spectator information during the briefing. **NO DOGS** are to be present during the Handler's Briefing

From the east, take I-90 to the Route 47 exit. Go north on Route 47 approximately 3.7 miles to Oakcrest Drive and turn left (known as Algonquin Road to the right). Go less than .1 miles on Oakcrest to Wolf Drive and turn left.

From the west, take I-90 to the Route 20 exit. Go west (left) 1.6 miles to Harmony Road. Turn right on Harmony Road and drive 3.7 miles to the stop sign, then turn left to stay on Harmony Road. Drive to the next stop sign and turn right (Main Street). Drive 1.4 miles on Main Street to Route 47 and turn left. Go .4 miles north on Route 47 to Oakcrest Drive and turn left. (Algonquin Road to the right). Drive approximately .1 miles to Wolf Drive and turn left.
