It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Each judge will take a lunch at his/her discretion.

Indoor crating is available. Crate mats are required to be placed under dog crates in the building.

Snacks will be available for exhibitors. Exhibitors may not set up on Thursday or before 7:00 a.m. on Friday. Crating space and exercise areas will be designated; please use the appropriate areas for each.

DIRECTIONS TO TRIAL SITE: Stone City Kennel Club is located approximately 4 miles west of Rt. 45, or 1 mile east of Cedar Road on Laraway Road in New Lenox.

FROM I-80 (eastbound) take Rt. 30 exit south. Go 1.5 miles

and turn right onto Cedar Road. Go 2 miles and at 4-way stop sign turn left (east) onto Laraway and go 1 mile. Clubhouse is located on the North side of the road.

FROM I 80 (westbound) take Rt 45 exit south. Go 5.6 miles and turn right onto Laraway Road and go approximately 4 miles west. Clubhouse will be on your right.
