Thank you for entering Stone City Kennel Club's obedience trials. These events are being held at the Stone City Kennel Club building, 13606 W. Laraway Road, New Lenox, IL 60451.

Running order will be tall to small each day.

Please check the included entry information for your dog(s). If you find any errors notify the trial secretary via email at secretary@livetrial.net or phone at (630) 790-8426.

The building will be open at 7:00 a.m. Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

#### CHECK IN INSTRUCTIONS.

Check in will be drive up. Please pull up to designated area. There will be a separate entry door for each ring. MASKS ARE REQUIRED AT TIME OF CHECK IN AND ENTRY INTO BUILDING.

- 1.) A volunteer will approach the vehicle for a temperature check. Your temp will be recorded on our waiver and handed to you to fill out.
- 2.) Give volunteer your check in information. The volunteer will then retrieve your check in materials (arm band numbers, Window numbers and any additional information regarding the trial)
- 3.) When volunteer returns, hand in filled out waiver to receive your colored entry wrist band and check in materials. You must have your wrist band on to enter the building.
- 4.) There will be a large copy of your Arm band number please display this in the window of your vehicle facing the aisle of the parking lot.

Please note Will County has tightened restrictions. As we are running at low capacity for a normal trial, we do ask if you to please social distance, and avoid clustering. Hand sanitizer is available inside and at entry doors. If you have any questions, please see Show Chair.

Please remember lunch will not be provided so prepare accordingly.

Each judge will take a lunch at his/her discretion.

PLEASE NOTE: No indoor crating is allowed for this trial.

### Stone City Kennel Club Covid 19 Rules

- 1. All people MUST wear a mask, refusal will result in forfeit of run and will be ask to leave the property.
- 2. All people entering the building must have a signed Covid Waiver.
- 3. Each day, every individual entering the building will have their temperature taken and recorded on the Waiver Form.
- 4. Everyone who signs a Waiver form and has an acceptable temperature will receive a wristband that will allow them into the building each day Friday, Saturday, and Sunday.
- 5. The waiver will be apart of the check in process.
- 6. Check in will be outside, you will check in, have your temperature checked, sign the waiver and be provided with your materials for the show.
- 7. Please maintain a 6-foot social distance between people outside of your party at all times. We understand that with multiple dogs you may need more than one person to maintain care.
- 8. Dogs will be crated in vehicles.
- 9. There will be NO spectators inside the building to either sit by your dog or to watch the judging.
- 10. There is a maximum of 10 people in the building at one time. If you are not in the ring with your dog, please go outside.
- 11. Only the handlers that have a dog in the ring and next two dogs may be inside to be ready.
- 12. There will be a 5 minute break or until all dogs are accounted for between classes. This gives everyone time to get their next dog.
- 13. Please be respectful of our neighbors concerning noise and pick up. This is a self-cleaning show so please pick up behind your dog including any loose hair and/or human garbage.
- 14. There is no overnight parking.
- 15. Please follow these rules as they are set up by the AKC and Will County. We must abide by them or you will be asked to leave.
- 16. Rules can change at any moment and we will advise you of any changes that occur.

Thank you for coming to our show and adhering to these rules. We could not have the show without them.

**DIRECTIONS TO TRIAL SITE:** Stone City Kennel Club is located approximately 4 miles west of Rt. 45, or 1 mile east of Cedar Road on Laraway Road in New Lenox.

**FROM I-80 (eastbound)** take Rt. 30 exit south. Go 1.5 miles and turn right onto Cedar Road. Go 2 miles and at 4-way stop sign turn left (east) onto Laraway and go 1 mile. Clubhouse is located on the North side of the road. **FROM I 80 (westbound)** take Rt 45 exit south. Go 5.6 miles and turn right onto Laraway Road and go approximately 4 miles west. Clubhouse will be on your right.


Turn left. Clinic is in the mall on the right past the Berkot's.
