A maximum of ten (10) dogs may be submitted per envelope of entries. Entries that are incorrect, illegible, or incomplete will not be accepted and will be returned to the exhibitor.

Express mail entries must waive the signature requirement or they will be refused.

Exhibitors are responsible for complete, accurate and legible information on their entry forms. All illegible or incomplete forms may be returned without prior notification to the exhibitor. Trial secretary assumes no responsibility for incorrect entry information due to illegibility of the entry. Entries will not be accepted without proper fees and signatures. Entries must be submitted on entry forms with the AKC agreement printed on the reverse side. Entries submitted without the agreement will be returned. If any exhibitor wishes to know that he made it into the trial, he must either include a valid email address on the entry form (preferred) or include a self-addressed stamped postcard or envelope.

NOTICE TO EXHIBITORS:

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All handlers must pick up after their dogs. Anyone not cleaning up after his or her dog will be requested to leave the trial.

The owner/handler of each dog is solely responsible for having it ready at ringside when the class is to be judged. Please help your fellow competitors, the trial workers, and the judge by checking in with the gate steward well ahead of your run, and being prompt at the line when your turn comes to run.

REFUNDS: Entry fees will not be refunded in the event that a dog is absent, excused, disqualified or barred from the competition by action of the Show Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other cause beyond control of the organizing committee. Entry fees will not be returned after the closing date for any reason with the following exception: bitches that come in season may have their entry fee returned, less an \$8.00 per day administrative fee, by sending a signed statement from a veterinarian, on their letterhead, to the Trial Secretary by 8:00 a.m. the day of the Trial.

PRIZES AND AWARDS: Dogs must qualify to receive awards. Qualifying rosettes will be awarded to all dogs receiving a qualifying score. Placement rosettes will be rewarded for 1st through 4th place in each class in each height division. New title rosettes will be awarded to dogs completing an agility title at this trial. All prizes must be claimed at the trial; none will be mailed. Additional special prizes will be available and are described in the center pages of this premium.

Dogs receiving a MACH or PACH will receive a rosette and award bar. Dogs receiving a PAX title will receive a rosette. Please contact the trial secretary at secretary@livetrial.net if you think you may complete one of these titles at this trial.

MOVE-UP REGULATIONS: Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made in writing to the trial secretary only. Forms may be mailed to Robert Olson, 817 Ogden Ave. #3549, Lisle, IL 60532-8549 or emailed to secretary@livetrial.net. No phone move-ups.

Pretrial moveups (for either day) must be received by the trial secretary by 6:00 p.m. Sunday, April 11, 2021.

Day to day moveups are offered, and must be received by the trial secretary in writing at the trial site by the end of ribbon awards on Sunday, April 18, 2021.

Dogs so moved up will be entered at the end of the running order, and every effort will be made to accommodate handlers running multiple dogs the same class. A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to the Novice "B" class.

DOGS ELIGIBLE TO ENTER: All collies fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) are eligible to participate, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

SAFETY: The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

COURSE FAMILIARIZATION/OBSTACLES: Handlers are permitted to walk the course, without a dog, prior to the start of the class. A walk-through period will be held prior to each class. The walk-through may be split at the judge's discretion. The judges briefing will outline the course and answer handler questions. Obstacles will meet the specifications for obstacles in the current edition of the regulations for Agility Trials. There will be no contact familiarization for Novice dogs at any of these trials.



COLLIE HIT AGILITY DOG - AWARD SELECTION PROCESS

CCA shall offer one High in Trial (HIT) agility award each day at the National Specialty. The prize will be a piece of Collie Art.

Only qualifying scores from the regular Standard and Jumpers with Weaves (JWW) classes count towards HIT. Preferred classes and additional classes, such as FAST and T2B, do not count towards HIT. For purposes of the HIT award, a "double Q" is defined as qualifying in both Standard and JWW, any level, or a combination of levels, on a single day of the agility trial.

Classes are weighted as follows:

- Novice classes receive 90% of their score
- Open classes receive 95%, and
- Excellent/Masters receive 100%.

Additionally, collies receive one point for each full second under standard course time (SCT).

The HIT award is calculated by adding the weighted score of each of a collie's qualifying runs (Standard and JWW) plus one point for each full second under standard course time (SCT). The collie with the highest total score under this formula wins the HIT award.

If no collie earns a "double Q," then the HIT award will be determined by calculating only the weighted score for Standard runs plus one point for each full second under SCT for the Standard run.

In the event of a tie, the tie will be broken by calculating the seconds under course time including the fraction of a second, instead of a full second. For example: SCT = 65 seconds. Dogs time = 44.35 seconds. Time under SCT including fraction is 65-44.35 = 20.65 seconds.

A MACH / PACH bar and rosette will be provided for dogs earning these respective titles at the show. Please contact Robert Olson at secretary@livetrial.net if you think you may complete one of these titles at the show.

Tied scores will be broken with the fastest yards per second based on the dog's time and the standard course distance.

IMPORTANT NOTICE

With your confirmation of entry you will receive three notices from the CCA committee. These pertain to requirements due to COVID-19 precautions. These notices also accompany this premium. Please read over them prior to submitting your entry.

- Practices and Guidelines. Some are different from the basic premium requirements at the herding site.
- 2. Liability Waiver: This needs to be completed and signed prior to entering the herding trial grounds.
- COVID -19 Self-Declaration/Contact Tracing Form: this needs to be completed and signed prior to entering the herding trial grounds.

PLEASE COMPLETE THESE FORMS AND BRING THEM WITH YOU. Extra forms will be available but you will save a lot of time if you bring completed forms with you.

MOST VERSATILE COLLIE IN THE 2021 NATIONAL SPECIALTY SHOW

To be eligible for this award a Collie must participate in at least three of the four AKC events offered by the CCA (Breed, Obedience/ Rally, Agility or Herding). Sign up for the award at any performance event. You must sign up for the award to be eligible, and signup sheets must be turned in to Beth Elliott by the end of the agility trial. The detailed rules for determining the winner from the Collies that qualify for the award are given below. Note that weighting factors are used in each of the performance events to recognize the increased difficulty of the higher level classes. In the Non-Best of Variety classes, points are awarded based on the number of dogs defeated in the class. All scores will be recorded from the posted Judge's sheets. Beth Elliott will maintain the official scores at this show.

The award presentations will be announced on Saturday, April 24, 2021 in the main conformation ring (Time TBA).

MOST VERSATILE COLLIE PRIZES

Most Versatile Collie in Show: CCA 15" Silver Plated Loving Cup Travel Case with original artwork by Martha Roeder Most Versatile Collie Qualifiers: Rosette

MOST VERSATILE COLLIE IN SHOW 2021

To be eligible for this award, your Collie needs a qualifying score in at least three of the four AKC events at the National Specialty. A Collie that receives MVC points in Breed is considered to have received a qualifying score in that event. Only one score will be counted for each event. The Collie obtaining the highest point total will win the award. The following scoring system will apply:

Breed:

- All Collies that are a conformation champion or have at least 5 championship points will receive a minimum of 40 MVC points for entering and showing in a conformation class at the CCA National.
- Collies with less than 5 Championship points will not automatically receive any MVC points for showing in a conformation class. Points will only be awarded for placing in a class and defeating competition.
- Since this is an individual award, Brace Class performance do not count. No points will be awarded to Collies entering a conformation class and not showing (i.e. marked absent).
- In the BOV class and Winners competition, points will be awarded as follows:
 - o Making no cuts: 40 points
 - o Making first cut: 50 points
 - Making second cut: 60 points
 - o Making third cut: 70 points
 - o Awards of Merit: 80 points
 - o Select Dog or Bitch 85 points
 - Reserve Winners: 75 points
 - o Winners: 80 points
 - o Best of Winners: 85 points

- o BOS to BOV: 90 points
- o Best of Variety: 100 points
- In all other conformation classes, points will be awarded based on the number of dogs defeated in that class as follows:
 - No placement: 40 points for Conformation Champions and Collies with 5 or more CH points, 0 points for Collies with fewer than 5 CH points
 - Placements: Two (2) additional MVC points are awarded for every dog defeated in the class up to a maximum total number of 70 MVC points. (Collies with less than 5 CH points will also receive the base 40 MVC points for placing and defeating dogs in a class.)

Herding Test and Trial: (No points are awarded for Herding Instinct or Exhibition Only entries)

- Herding Tested Class: Passing: 50 points
- Pre-Trial Tested Class: Passing: 50 points
- Started Trial Class: 90% of total score (out of 100)
- Intermediate Trial Class: 95% of total score (out of 100)
- Advanced Trial Class: 100% of total score (out of 100)

Obedience & Rally Trial:

- Beginner Novice: 40% of total score (out of 200)
- Preferred Novice: 43% of total score (out of 200)
- Novice and Veteran: 45% of total score (out of 200)
- Graduate Novice: 46% of total score (out of 200)
- Open and Preferred Open: 47% of total score (out of 200)
- Graduate Open: 48% of total score (out of 200)
- Utility and Preferred Utility: 50% of total score (out of 200)
- Rally Novice: 60% of total score (out of 100)
- Rally Intermediate: 67% of total score (out of 100)
- Rally Advanced: 75% of total score (out of 100)
- Rally Excellent: 90% of total score (out of 100)
- Rally Master: 94% of total score (out of 100)

Agility Trial:

Standard and JWW Classes, both Regular and preferred:

- Novice: 90% of total score (out of 100)
- Open: 95% of total score (out of 100)
- Excellent/Master/Premier: 100% of total score (out of 100)
- FAST: 125% of total score (out of 80)
- Time2Beat: 95% (90 + T2B points earned)

Class Changes Effective January 1, 2021 Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2021, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Entering For Exhibition Only (FEO)

As of January 1, 2021, For Exhibition Only may be offered at the option of the host club. FEO will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an
 ineligible jump height, the team is committed to FEO for that run and must
 declare FEO on the start line. Day of show jump height changes are not
 allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master).
 If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
 - o Toys must be non-audible
 - O Toys may not leave the handler's hand
 - o Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

Fix and Go On (FNG)

As of January 1, 2021, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

AGILITY Practices & Guidelines

MASKS WILL BE REQUIRED TO BE WORN BY EVERYONE AT ALL TIMES

If you refuse you will be asked to leave the show ground without refund of ANY fees previously paid.

1. Admittance to the event areas

- a. Please be patient if there are lines.
- b. Each day Agility entrants **MUST** check in at the **EAST ENTRANCE DOOR to the Dirt barn** before entering **ANY** buildings or event areas.
- c. **EVERYONE** must <u>initially</u> turn in a signed **Waiver**, a **COVID Declaration/Contract Tracing** form, have your temperature checked, and receive a wrist band. Forms will be available at check in but to expedite the lines, please print the forms ahead of time and have them filled out when you arrive. Forms will also be available on the CCA National website and the Trial Secretary's website.
- d. You **MUST** wear your wristband at **ALL** times while you are on the show grounds. This signifies that you have submitted your required forms and have had your temperature checked.
- e. **EACH** day thereafter you must check in again and have your temperature taken. You will receive a sticker if your temperature is within the acceptable range. You **MUST** wear this sticker in a visible place on your person at **ALL** times.
- f. If you are not wearing a wristband, you will be directed back to the check-in areas to fill out the required forms and have your temperature checked before being allowed into any building or event area.
- g. If you do not have a sticker, you will be directed back to the check-in area to have your temperature taken and receive a sticker before being allowed into any building or event area.

2. Inside Event Buildings and Event Areas

- k. Avoid common use pens/pencils bring your own.
- I. Please consider leaving the grounds once you are done for the day.

3. Exhibitors

- a. Prepare to be self-sufficient: bring your own sanitizers, hand wipes, and masks.
- b. Know your arm band number before you go to the ring.
- c. Follow all instructions given by the ring stewards for entrance to and exit from the ring and the ring area.
- d. Do not gather for your walkthrough until called.
- e. Remember to keep the 6' social distance between you and other exhibitors both inside and outside of the rings.
- f. This is a self- cleaning show, please be aware of what your Collie is doing! Be prepared to clean up after your own dog.
- g. **NO** private chairs will be allowed around any rings.
- h. Spectator numbers MAY be limited based on current Laramie County/Wyoming restrictions.
- i. Food Trucks will be available, and you are allowed to bring your own food.
- j. Please dispose of all used masks and gloves in appropriate waste receptacles.
- k. It is strongly suggested that each exhibitor have a contingency plan in place for themselves and their dogs in case of sudden illness.

4. Crating

- a. All crating spaces will be socially distanced and planned.
- b. Additional crating space will be available in an adjacent room.
- c. No electric will be available in the crating areas.
- d. There will be **NO DRYERS OR FANS** allowed in the crating area.
- e. Only battery operated crate fans will be allowed on individual crates.
- f. If your dogs are left overnight in the building, make sure their crates have an emergency card attached with the Dog's Name, Your Name, and a cell phone number to reach you.
- g. Dog bathing stations will be available. You must bring your own shampoo and towels.
- h. There will be two drying stations (tables) set up outdoors for your use. Electricity will be available here; you will need to bring your own dryer.
- i. Avoid displaying high touch items in your crating areas: bowls of candy, photo albums, pedigrees etc.
- j. Consider bringing disinfecting spray to spray down surfaces that are touched by many people.
- k. Please consider crating dogs in your vehicle if the weather is acceptable.
